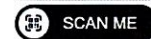

# **Hudson County Central Labor Council**

## **2026 Ed Pulver and Donna Benjamin (Scholarship Application)**

- 1- To be eligible for a scholarship, the applicant's Parent or legal Guardian must be a member of a local union affiliated with the Hudson County Central Labor Council, AFL-CIO, or his/her spouse and/or children and or registered apprenticeship program that falls within the scope of work of a union affiliated with the Hudson County Central Labor Council, AFL-CIO.
- 2- Each application must be accompanied by a transcript from your most recent institution of learning.
- 3- Each applicant must be accompanied by a short essay of 500 words or fewer outlining their career goals, aspirations, and work experience. Describe your connection with the union and the labor movement. Explain why you are a good choice for a union scholarship.
- 4- The scholarship shall be applicable solely for an accredited college or accredited post-high school educational program, an approved and registered apprenticeship program that falls within the scope of work of a union affiliated with the Hudson County Central Labor Council, AFL-CIO.
- 5- The recipient of the scholarship must be enrolled at an accredited college or accredited post-high school program and/or registered apprenticeship program that falls within the scope of work of a union affiliated with the Hudson County Central Labor Council, AFL-CIO.
- 6- Scholarships are granted for a duration of one (1) academic year. To promote equitable access across all affiliated unions and their dependents, recipients are not ineligible to receive the scholarship in consecutive years.
- 7- The scholarship will be available to both full and part-time students.
- 8- The Scholarship Selection Committee shall recommend recipients for the award based on merit, which will be determined by scholastic ability or its equivalent. Consideration of financial need will be entered only under extraordinary circumstances.
- 9- All applications must be sent by US Mail to **154 Ridge Road, Lyndhurst, NJ 07071**. and or all applications/information should be received not later than **July 1, 2026**
- 10- Fourteen (14) scholarships will be awarded:

- Three (3) Edward B. Pulver Scholarship \$1,000.00 each.
- Three (3) Donna Benjamin Scholarship \$1,000.00 each.
- Eight (8) Tradre scholarships of \$500.00 each.
