REQUIREMENTS

1. An applicant's parent or legal guardian must be a member of a local union affiliated with the Hudson County Central Labor Council, AFL-CIO.
2. All requirements must be satisfied and all requested information submitted for the application to be considered.
3. Each applicant must include their most recent transcript from the institution in which they are currently enrolled. All applicants must submit complete copies of their official transcripts. If you are currently enrolled in college, you must submit your college transcripts and any other supporting documents.
4. Each application must be accompanied with a short essay of 500 words or less that describes your experiences with the labor movement.
5. A letter of recommendation from a guidance counselor or teacher.
6. Any record of community service or extracurricular activities.
7. The recipients must be applying to or enrolled in an accredited college, nursing school, or technical school.
8. The scholarships are available to Full Time and Part Time students.
9. The scholarships will be granted to students for a period of one academic year. You may reapply for a scholarship but will only be eligible for the first four years.
10. Ten scholarships will be awarded:
 - a) Two scholarships of \$1,000 will be for merit based on scholastic achievements in the Edward B. Pulver Scholarship awards and two scholarships of \$1,000 will be awarded based on merit for scholastic achievements in the Donna Benjamin Scholarship awards.
 - b) Two scholarships of \$1,000 will be awarded to students that show evidence of significant achievements for the Edward B. Pulver Scholarship awards and two scholarships of \$1,000 for evidence of achievements for the Donna Benjamin Scholarship awards.
 - c) Two scholarships of \$1,000 will be awarded to a special needs student. Proof of eligibility required. Must be provided by the applicant, child study team or a guidance counselor.
11. All applications will be reviewed by the Hudson County CLC.
